IT IS THEREUPON ORDERED AND ADJUDGED as follows:


1. The report of Wm. Fletcher Belcher consisting of the Schedule of Distributions, Schedule of Supplemental Receipts and Disbursements and Second Schedule of Supplemental Receipts and Disbursements, is approved;
2. Wm. Fletcher Belcher is discharged and relieved from any further responsibility to receive, accept, deposit and disburse funds pursuant to the Order Directing Distribution dated

October 11, 1996, previously entered in this action.

3. State of Florida Department of Corrections shall discontinue forwarding to Wm. Fletcher Belcher payments received by it in restitution or reimbursement of trust funds embezzled from the Myrtle Dent Trembley Trust by Dennis D. Correa, the former Trustee of said Trust, and shall deposit all such payments received by it in the future into the registry of the above-styled Court by checks payable to the order of Clerk of Court.

4. The Clerk of this Court shall accept funds into the registry of this Court from the State of Florida Department of Corrections in accordance with the previous paragraph and shall retain said funds in the Court registry pending further order of this Court upon its own motion or upon the motion of the Clerk of this Court, State of Florida Department of Corrections, or any person or entity having an interest in the Myrtle Dent Trembley Trust.
