APPELLANT'S MOTION TO COMPEL CLERK TO CORRECT AND PREPARE INDEX AND RECORD

Appellant pro se Neil J. Gillespie hereby moves the Court for an Order to Compel the Clerk to Correct and Prepare Index and Record and in support thereof states:

1. By Order dated February 17, 2011 this Court granted appellant's motion to

extend the time for the preparation of the Index and Record for thirty days.

2. Appellant has been working diligently with the Clerk of the Court of the

lower tribunal to correct omissions and other issues related to the record as reflected by the Index prepared by the Clerk. Specifically appellant has been in communication with Mark Ware, Esq., Director of Appeals, Clerk of the Circuit Court, Hillsborough County,

and Lisa Mann, Associate Director of the Appeals Department.

3. As of today, and the filing of this motion, the Clerk of the Circuit Court,

Hillsborough County, has not provided appellant a corrected or amended Index.

4. The following is a timeline of events:

a. February 24, 2011 Mr. Ware provide appellant by email the results of the Clerk's "diligent and meticulous research" of the Index and Record along with six

Attachments numbered 1 - 6. Among other things Mr. Ware informed appellant that the following two (2) documents shown on the Clerk's progress docket could not presently be found in the Clerk's file and that "we will file a Clerk Certificate with the District Court advising the District Court that we cannot locate the document." Those documents include the following:

(i) Attachment 2: Will Add to Record – Requested Items That Should Have Been in the Record ...There is also one missing item in this request, it is: 07/20/10 Plaintiff's Notice of Filing Affidavit, Neil J. Gillespie, no signed contract. The document appears to be the Affidavit docketed on 07/23/10 as Affidavit of Neil J. Gillespie. In this circumstance, we will file a Clerk Certificate with the District Court advising the District Court that we cannot locate the document.

(ii) Attachment 4: Items Filed in Case But Not Requested...There is also one missing item, it is: 06/03/10 Notice of Filing Affidavit of William J. Cook, Esquire. Please let me know if you want us to add any of these documents to the Record. If you request to add the missing document, we will prepare another Clerk Certificate (see Attachment 2 above).

b. March 10, 2011 appellant served <u>Notice of Filing Transcripts</u> at the request of Mr. Ware to add missing transcripts to the Clerk's court file, progress docket, Index and Record. Mr. Ware identified missing transcripts in his email to appellant February 24, 2011. A copy of <u>Notice of Filing Transcripts</u> is attached as Exhibit A. Appellant's former counsel Robert W. Bauer, Bar ID 11058, failed to file some of the transcripts during his representation of appellant. Mr. Bauer is currently a respondent in appellant's Bar complaint. Brian S. Kramer, Esq., was the investigating member for the grievance committee. Appellant contacted Mr. Bauer about the missing transcripts March 3, 2011 and March 5, 2011 but he failed to respond. Mr. Kramer suggested appellant make a new Bar complaint against Mr. Bauer for misconduct relating to the transcripts.

c. March 14, 2011 appellant notified Mr. Ware and Ms. Mann that he would rely upon the information provided by Mr. Ware February 24, 2011 and to proceed with the corrected or amended Index and Record. For a time appellant considered submitting Amended Directions to Clerk but abandoned that effort as too complex. Appellant requested several additional documents be included. Appellant also asked Mr. Ware who filed Appellant's confidential medical information with the Clerk. The Clerk's progress docket shows an entry June 21, 2010 "Envelope Filed With Documents" and "Confidential Envelope Addressed to Judge Barton With Contents: 1. ADA Assessment and Report, Karin Huffer, MS, MFT. 2. ADA Accommodation Request of Neil J. Gillespie 3. Notice of ADA Accommodation Request of Neil J. Gillespie. 4. Transcript, Hearing Before The Honorable Claudia Isom, February 5, 2007." A copy of the Clerk's progress docket page showing the entry is attached as Exhibit B.

d. March 15, 2011 Mr. Ware responded in part with additional questions and wrote "If you are able to respond to us quickly, we will try to meet the date set by the Second District Court of Appeal in its order dated February 17, 2011. That has been, and continues to be, our goal. Once we have completed the Index, we will forward it to you for your review. When we receive your approval, we will send the Index to you and the Appellee. The Index and Record will be sent to the Second District Court of Appeal after all briefs have been filed with that Court." Appellant responded two hours later but has not heard back from Mr. Ware. Among other things, appellant asked Mr. Ware "Have you received a response from Judge Barton to my letter of February 3, 2011 requesting he file letters in this case with the clerk?"

5. Pursuant to Fla. R. App. P., Rule 9.300(b) service of a motion shall toll the time schedule of any proceeding in the court until disposition of the motion.

WHEREFORE, Appellant pro se, NEIL J. GILLESPIE, respectfully moves this Court for an <u>Order To Compel Clerk to Correct and Prepare Index and Record</u> and other relief as this Court deems necessary under the circumstances.
