ADDENDUM TO PETITIONER'S MOTION FOR EXTENSION OF TIME TO FILE PETITION FOR WRIT OF MANDAMUS

BELATED SEPARATE REQUEST TO TOLL TIME

- 1. Petitioner filed December 19, 2011 a motion to extend time to file a petition for writ of mandamus. At the time Petitioner's computer was being repaired by Abshier Consulting, Inc. (ACI) computer repair shop in Ocala, Florida. Petitioner lost access to his files and could not state further at that time.
- 2. The computer was returned December 21, 2011. A copy of the invoice from ACI is attached as Exhibit 1. Once the computer was returned it took several more days to be fully functional, as all the files, data and programs had to be reinstalled. Some of the files did not transfer properly and additional time was needed to correct that issue. Many of the programs required additional time to set up and re-calibrate settings. The computer was not fully operational until December 26, 2011.
- 3. For much of the month of December Gillespie's computer was infected with a virus and not usable. This problem began December 3, 2011 and the computer was taken for repair at ACI. The computer was returned December 6, 2011. A copy of the invoice is

attached as Exhibit 2. But the virus was not completely removed and problems continued until the computer stopped working again December 15, 2011. The computer was taken back for repair to ACI. It was determined that the virus could not be removed, and the only remedy was to completely scrub and reformat the computer's hard drive. This meant that all Gillespie's files, data and programs were lost and had to be reinstalled. This was a lengthy and time intensive project.

- 4. Gillespie will serve the petition January 6, 2012.
- 5. Pursuant to Rule 9.300, Fla. R. App. P., Petitioner moved December 19, 2011 for a third extension of ten (10) days time, with a date certain of January 6, 2012 in which to file his petition for writ of mandamus. Gillespie will serve the petition January 6, 2012. Pursuant to Rule 9.300(d)(10), Gillespie belatedly requests the Court to toll time.

WHEREFORE, Petitioner moves for an extension of ten (10) days time, with a date certain of January 6, 2012 in which to file his petition for writ of mandamus, and belatedly request the Court to toll time.
