 Mr. Leffel,

Would you reconsider your decision to represent me? There have been several new developments in my case. I was declared indigent under section 27.52 and the public defender was appointed for the contempt hearing. When the PD arrived, the court issued an order relieving the PD, see attached. An arrest warrant was issued. I hired a lawyer on craigslist who moved to quash the writ of bodily attachment, but the court denied that, and offered to conduct a deposition in the courthouse while I was in custody. I agreed and voluntarily appeared. I was taken into custody and essentially held until I agreed to a settlement. I didn't understand the settlement until later, and have moved to strike or set it aside. Attached is the motion I filed in US District Court today. James Burkhold, Clerk of the 2dDCA, encouraged me to file a similar motion to reinstate appeal 2D10-5179 which I will do tomorrow. Thank you.
