## **Federal Older Americans Act**

- •The Department of Elder Affairs is designated as the state unit on aging as defined in the federal Older Americans Act (OAA) of 1965.
- •The department is required to carry out the responsibilities detailed in the OAA, including organizing, coordinating and providing community based services and opportunities for older Americans and their families.

### **Legislative Enactment**


- Authorized in 1991 per an amendment to the Florida Constitution, Article IV, Section 12.
- Created in the "Department of Elderly Affairs Act," Section 20.41 and Chapter 430, Florida Statues.

**Department Profile** 

The department was created as a result of a constitutional amendment in 1988 and established in statute in 1991. The department began operation in January 1992 with the legislative responsibility of being the primary agency for administering human service programs for the elderly and developing policy recommendations for long-term care. The department's purpose also includes combating ageism, creating public awareness and understanding the contributions and needs of elders, advocating on behalf of elders, serving as an information clearinghouse, and preparing our communities for retirement. - 41,000+ volunteers assist DOEA in delivering messages about services.
- DOEA is 94 percent privatized through contracts with other entities.

#### **Clients Served**

- Approximately 207, 841 elders age 60 and older received direct services funded through the department's programs during FY 06-07.
- An additional 450,000 elders received services through counseling, information and referral and other outreach efforts.




