This is in response to your E-mail to Chairman Julie Brown, Florida Public Service Commission (FPSC), regarding Sumter Electric Cooperative (SECO). Given the nature of your concerns, Chairman Brown feels it would be appropriate for specialized staff of the Office of Consumer Assistance and Outreach to respond to you.

The FPSC regulates investor-owned electric, and natural gas utilities throughout the state, and investor-owned water and wastewater utilities in those counties which have opted to transfer jurisdiction to the FPSC. The FPSC has limited authority in the telephone industry to include the Lifeline Assistance Program, Florida Relay Service, and pay telephone service. The FPSC does not have rules that address service or billing issues for electric cooperatives.
