Today Heather Hedges-Large, Ocala Police Department, Records Management Supervisor responded to my call, which was taken by Marion County Public Safety"

Mr. Blevins, Provide my 911 call on January 2, 2025 regarding Harold Minnis.

Provide the voice recording of my 911 call on January 2, 2025.

I am providing this email to counsel of record for Mr. Minnis, Tracya N Smith, Assistant Public Defender, U.S. Congresswoman Kat Cammack who previously made an inquiry on behalf of Mr. Minnis. I am also providing this to Hunt Murty of Magnolia Media Co. publisher of the Ocala Gazette who has reported on the 911 system.

My 911 call on January 2, 2025 regarding Harold Minnis concerned violation of his civil rights, and Mr. Minnis offered to surrender at the Marion County Jail, but was refused. I know this because I drove to the jail and the jail refused to take him into custody, I called 911. Provide the voice recording of my 911 call on January 2, 2025.

On January 29, 2025 Mr. Minnis was arrested and is currently held in the jail for the same issue for being homeless. The case in Marion County Florida is No. 2025-CF-0383, Judge Robert Hodges presiding. The arraignment is scheduled for the arraignment on March 4, 2025. McCount is a former prosecutor, and former genealogist with the Sheriff's Office.
