Your Honor:

Please find enclosed a transcript of my 911 call January 2, 2025 in this case to be included in the record. I am Neil J. Gillespie, a nonlawyer advocate d/b/a Justice Network. Harold Minnis was a client of mine. I am a material witness in this matter. On January 2, 2025 I drove Harold Minnis to the Marion County Jail to surrender because he was homeless and unable to report a change of address, because he had no address; Harold was homeless and living on the street.

Unfortunately the Marion County Jail refused to accept Harold, so I reported this as an emergency call to 911. Previously I provided this information to Harold's pubic defender, Tracya N Smith, Florida Bar No. 1027725, but got no response. The docket for State v. Minnis, case no. 2025-CF-0383, maintained by Gregory Harrell, Clerk and Comptroller, does not show an attorney for Mr. Minnis. The docket shows "Bar ID 88888888" by Harold's name.

In my view, if a suspect surrenders to law enforcement, as Harold Minnis did on January 2, 2025, law enforcement has a duty to take him into custody. But law enforcement refused to incarcerate Mr. Minnis. I am willing to testify at trial for the defense. The State was reckless and put the public in danger by failing to incarcerate Mr. Minis as he requested. Separately, for 27 days Harold Minnis incurred medical costs ultimately paid by the taxpayer, perhaps hundreds of thousands of dollars in hospital stays and ambulance rides, just to later throw him in jail anyway.

Harold Minnis is age 63 and has End-Stage Renal Disease (ESRD). Harold needs kidney dialysis three times a week in order to stay alive. Harold is not a candidate for a kidney transplant. The Marion County Jail provides kidney dialysis to inmates, along with food, clothing and shelter.

Harold initially applied for SSI in Ocala on Sep-10-2024 @ 12:41 PM #W509. His application was pending. Otherwise Harold did not have money and could not pay his rent at [REDACTED] Dunnellon, FL 34432. As shown in my 911 call, Harold was being beaten by other people in the home. I provided Ms. Smith a video showing Harold's disability climbing steps to the home. The landlady, [REDACTED], said the home was not compliant for people with disabilities. This home is in a remote location on a dirt road with no public transportation.

July 21, 2025

Subsequently Harold was diagnosed with End Stage Renal Disease (ESRD). Harold applied for ESRD benefits in person on Jan-17-2025 @ 9:00 AM and spoke with Mrs. Nelson, who provided a End Stage Renal Disease Medical Evidence Report form, to be completed by AdventHealth Ocala the provider who provided kidney dialysis for Harold.

Harold had a telephone appointment scheduled with Social Security on January 30, 2025. I received a telephone call from Amette Hernandez of Social Security on January 30, 2025 looking for Harold Minnis to conduct his appointment for a End Stage Renal Disease application. But Harold Minnis was arrested and incarcerated on January 29, 2025, one day beforehand.

Last week you filed notice of appearance for Harold Minnis as captioned above. I am Neil J. Gillespie, d/b/a Justice Network, a nonlawyer advocate for Harold, from the time of his release from prison on September 8, 2024 through January 17, 2025. My assistance to Harold has created a conflict that may prejudice his situation because local authorities oppose my efforts. I have explained this to Harold. I pay the bill for Harold's cell phone #352-355-0036 with Consumer Cellular. The phone is currently being held by the jail. I do not charge for my services. I am age 68 and rely of Social Security retirement income. I have posted my efforts with Harold on my Justice Network blog and Facebook, see

I met Harold in 2021 during my incarceration in the Marion County Jail, which was reported to the Federal Election Commission in my 2024 Year-End report here,

Harold has End Stage Renal Disease (ESRD) and needs kidney dialysis three times a week. Harold is (redacted). Please find attached Harold's authorization for me to discuss his situation. On January 30, 2025 I received a telephone call from Amette Hernandez of Social Security looking for Harold Minnis to conduct his appointment for a End Stage Renal Disease application. Previously I accompanied Harold Minnis to Social Security Ocala. Harold applied for ESRD benefits in person on Jan-17-2025 @ 9:00 AM (ESRD) and spoke with Mrs. Nelson, who provided a End Stage Renal Disease Medical Evidence Report form. I provided the ESRD form by email and hand delivery to AdventHealth Ocala and Jeffrey S. Bromme, Esq., AdventHealth Executive Vice President and Chief Legal Officer. I will forward my emails with AdventHealth, Mr. Bromme to you.

In my view the authorities violated Harold's civil rights and disability rights. U.S. Congresswoman Kat Cammack inquired on Harold's behalf and learned his application for SSI was pending, but due to insufficient work credits, Harold is not eligible for Social Security disability or retirement benefits. Without money, Harold could not pay his \$800 a month rent at [REDACTED], Dunnellon, FL 34432 to his landlord, [REDACTED] who also noted the home is not accessible for Harold. I have video of Harold struggling with a flight of steps to the home. Harold also had interpersonal issues with some of his roommates.

Harold's brother [REDACTED] had a place for Harold to stay at [REDACTED] Umatilla, FL 32784, but probation office Antonio Rameriz said the property was too close to a bus stop. In the past Harold lived at this address.

Lawyers I contacted refuse to help Harold, including a Florida Bar LRS referral, J.W. Chalkley, Esq., and the Morgan & Morgan Ocala law firm. West Marion Hospital caseworker Ms. St. Kitts said there was a "blockage in the county" preventing Harold from getting benefits. I will forward my emails with MCSO general counsel Marissa Duquette.

On January 2, 2025 Harold was homeless. I took him to the Marion County Jail where he voluntarily surrendered, but the jail ultimately refused him. I called 911 on Harold's behalf when he was left stranded outside the jail in freezing weather. So far the authorities have refused my public records request for the voice recording of the 911 call. (I used my iPhone to record part of the 911 call)

Harold's Pre-Release Plan from the Florida Department of Corrections has a referral to Catholic Charities, 1701 NE 9th Street, Gainesville, FL 32609 at 352-378-2868 for eligibility. For several months I have called and emailed Catholic Charities to no avail. Susan Frizzell, the Program Coordinator for HOPWA Eligibility Determination, has not

made a determination that I know about. HOPWA is a Federal program that could provide a grant for housing Harold Minnis.

Prior to Harold's release from prison, I was in contact with Warden Randall Polk, and Jerry Waters, Classification Supervisor, Columbia Correctional Institution. In September 2024 the Marion County Tax Collector initially refused to issue a state ID to Harold. I will forward those emails to you. Also my emails with the Marion County Health Department for (redacted) treatment.

I am willing to help Harold in any way I can. Thank you.

In addition, I provided Ms. Smith nine (9) additional emails documenting Harold's case with various agencies, medical providers, lawyers and LE. As of today Ms. Smith has not responded.

Please schedule my testimony on behalf of Mr. Minnis. Currently it does not appear Mr. Minnis has adequate counsel as required by the Sixth Amendment to the U.S. Constitution:

In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.

CALL-TAKER: 9-1-1. What is the address of the emergency?

MR. GILLESPIE: It's at the Marion County Jail.

CALL-TAKER: All right, the Marion County Jail?

MR. GILLESPIE: His name is Harold Minnis. He just called me a few minutes ago, you know, on the phone. He's age 63. I think he's in -- he might either hurt himself or hurt someone else.

He's on probation. He is a registered sex offender. He has nowhere to live. He got -- something happened with where he was living. He went down there today to the jail to report to Officer Nix and they don't have any housing for him. They told him to come back tomorrow.

He doesn't really have any winter clothing with him. He just has a, a shirt and a pair of pants.

So, you know, he, he's calling me. He wants me to take him to the hospital. I don't think the hospital wants him there. And if he needs to go to the hospital, he needs to go in an ambulance.

CALL-TAKER: Okay.

MR. GILLESPIE: So I'm just letting you know, --

CALL-TAKER: Okay.

MR. GILLESPIE: -- I'm letting you know, and I'm

1 going to give you all his information and -- because I
2 think it's my civic duty. I have to do this.

3 CALL-TAKER: I'm sorry. So did he say like why he
4 had to go to the hospital? Was it just for like housing
5 he tried to get, or --

6 MR. GILLESPIE: He is in end stage renal disease.
7 That means kidney failure. He has to get kidney
8 dialysis three days a week. That's, generally, why he's
9 at the hospital.

10 CALL-TAKER: Okay.

11 MR. GILLESPIE: He also has other health problems.
12 He recently had a heart bypass and he may need other
13 health things. I don't know. He's very quiet about his
14 health and he doesn't really let people help him, and he
15 just lashes out when things don't go his way.

16 So that's the situation I'm in. I've spent a lot
17 of money trying to help this man. I don't have any more
18 time or money. And it's a risk to me because he's
19 getting increasingly desperate.

20 So they let him out of AdventHealth Hospital this
21 morning. He called me. I picked him up over at the
22 Dollar Store at Pine and 17th. I took him to the jail,
23 and I told him that's it. I said, "If you, if you can't
24 get a place to live, you need to go back into jail."
25 He's on probation, all right. He should be back in

1 jail. That way, he'll have food, clothing, and medical
2 attention.

3 But out on the street, he is a danger to himself
4 and to other people.

5 CALL-TAKER: Okay. And so you said -- so he has at
6 the jail right now? Like he's, he's not inside? Like
7 he's at the jail?

8 MR. GILLESPIE: He was outside the jail.

9 CALL-TAKER: Okay.

10 MR. GILLESPIE: Yeah. If he was in the jail and
11 they would be --

12 CALL-TAKER: Yeah.

13 MR. GILLESPIE: -- taking care of him.

14 CALL-TAKER: I just wanted to double-check. And
15 what is a good callback number for you?

16 MR. GILLESPIE: 352-239-9037.

17 CALL-TAKER: And your first and last name?

18 MR. GILLESPIE: My name is Neil Gillespie.

19 CALL-TAKER: Okay, give me one second while I put
20 this information in. Just stay on the line with me and

14 people there. Some of them are sex offenders, so it's
15 an unruly group, and he's, you know, the odd man out.

16 CALL-TAKER: Okay.

17 MR. GILLESPIE: There's, you know, there's trouble
18 being made and they were, I guess, beating him up,
19 because, you know, he's 63, not a young guy.

20 CALL-TAKER: Okay.

21 MR. GILLESPIE: Somebody else --

22 CALL-TAKER: And are you, are you at the jail now,
23 too? Are you still at that location?

24 MR. GILLESPIE: No. No. No. I'm in my office.

1 said he's 63. Can I get his, his description, starting
2 with his race?

3 MR. GILLESPIE: Yeah. He's a black male.

4 CALL-TAKER: And what was he wearing today?

5 MR. GILLESPIE: He was wearing a gray pair of like
6 sweatpants and a grey shirt, like a pullover, I think it
7 was. He, he wears his ankle, an ankle monitor, too.

8 CALL-TAKER: Okay.

9 MR. GILLESPIE: So if he's not actually home or
10 somewhere that thing's going to go off. He tells me
11 that he spoke with his probation officer and they told
12 him don't worry about that. That doesn't sound right.

13 CALL-TAKER: Yeah. And does he have any physical,
14 medical, or mental conditions that we need to be aware
15 of?

16 MR. GILLESPIE: Yes. He's in end-stage renal
17 disease, kidney failure. I -- he, he probably has a
18 couple of strokes recently. You know, it's hard to
19 understand what he's saying. He kind of jabbers on and
20 on, without any real words coming out.

21 And he's got a heart condition. You know, he was a
22 lifetime smoker and everything's bad on him.

23 CALL-TAKER: Okay. All right. So I did put this
24 information in, so I am going to let you go now. So an
25 officer will be dispatched as soon as possible. So just

1 call us back if you need information, if you get new
2 information or need further assistance.

3 Would you like a call from the officer on like any
4 updates or anything?

5 MR. GILLESPIE: You can, if you want. Would it,
6 would it be helpful for me to call him? Because I can
7 give you his phone number. He's got a cellphone. Do
8 you want his phone number?

9 CALL-TAKER: Yes, I can get his phone number, as
10 well.

11 MR. GILLESPIE: 352-355-0036.

12 CALL-TAKER: Okay.

13 MR. GILLESPIE: Do you want his date of birth,
14 social security number, state ID? I've got all that.

15 CALL-TAKER: Okay. All right, so I did go ahead
16 and put all that information in. So if the officer does
17 call you, it's going to be on a block or restricted
18 phone number, so just keep an, an eye out for that,
19 okay?

20 MR. GILLESPIE: Yeah. His probation officer is
21 Officer Ramirez, and his reporting officer is Detective
22 Tasha Nix. She's well aware of the situation because
23 I've been emailing her and other people in the
24 government because he -- you know, he's (TECHNICAL
25 INTERRUPTION) know that. He could be getting care under

1 the Ryan White Act -- it's with the Catholic
2 charities -- and everyone is cutting him off for some
3 reason.

4 I spoke to his caseworker at West Marion Hospital,
5 a woman by the name of Ms. St. Kitts. She told me that
6 there's a blockage, that the County is showing him being
7 in the jail, so he can't get any benefits. He can't get
8 his Medicaid, Social -- you know, SSI, or anything else.

9 So it really seems like it's some kind of a setup
10 to harm him by the Marion County authorities. Because
11 he can't get his benefits and he's been, basically,
12 kicked out of his house, and he has nowhere to go. So
13 it seems like they wanted him like to just have a
14 complete mental breakdown, maybe get in a fight with
15 someone, and then they'll say, "Oh, look. He did this.
16 He did that, and we're going to throw him in jail for
17 ten more years." This is what's going on.

18 CALL-TAKER: Okay. So --

19 MR. GILLESPIE: And what's your name? What's your
20 name, ma'am?

21 CALL-TAKER: Jessica.

22 MR. GILLESPIE: You're Jessica. All right.
23 Because I'm making a record of this, you know, for
24 everyone's protection. And I know you're recording it,
25 right?

1 CALL-TAKER: Oh, yeah, they're recorded.

2 MR. GILLESPIE: All right.

3 CALL-TAKER: They're all public record.

4 MR. GILLESPIE: I want to get a copy of the
5 recording and, you know, I just want everyone to be
6 safe. And, right now, he's not safe because of the
7 situation, and it appears that the Marion County
8 government is involved in blocking his benefits, and
9 that includes the Catholic Church.

10 Because I also contacted lawyers to help him. And
11 you ever heard of the firm Morgan & Morgan? All right,
12 they were supposed to help him and they won't even
13 return my calls or answer my emails.

14 I also, from the Florida Bar Lawyer Referral
15 Service, I got a referral to Mr. Chalkley in Ocala. He
16 won't talk to Harold or take his case.

17 So, you know, there's too much blockage going on
18 between medical, legal, and housing. And this makes me
19 suspect that this isn't the way things are supposed to
20 run.

21 CALL-TAKER: Okay, I understand. So just keep a
22 look out for that blocked or restricted number. That's
23 the officer. I did put everything in for the officers
24 to know about him, and they might give you a call just
25 to get more information on him. So just keep a look out

1 for that, okay?

2 MR. GILLESPIE: Thank you.

3 CALL-TAKER: You're welcome.

Last week you filed notice of appearance for Harold Minnis as captioned above. I am Neil J. Gillespie, d/b/a Justice Network, a nonlawyer advocate for Harold, from the time of his release from prison on September 8, 2024 through January 17, 2025. My assistance to Harold has created a conflict that may prejudice his situation because local authorities oppose my efforts. I have explained this to Harold. I pay the bill for Harold's cell phone #352-355-0036 with Consumer Cellular. The phone is currently being held by the jail. I do not charge for my services. I am age 68 and rely of Social Security retirement income. I have posted my efforts with Harold on my Justice Network blog and Facebook, see

I met Harold in 2021 during my incarceration in the Marion County Jail, which was reported to the Federal Election Commission in my 2024 Year-End report here, <https://docquery.fec.gov/cgi-bin/fecimg/?C00627810> and here, https://docquery.fec.gov/cgi-bin/fecimg/?_202501319753183897+0

Harold has End Stage Renal Disease (ESRD) and needs kidney dialysis three times a week. Harold is [REDACTED]. Please find attached Harold's authorization for me to discuss his situation. On January 30, 2025 I received a telephone call from Amette Hernandez of Social Security looking for Harold Minnis to conduct his appointment for a End Stage Renal Disease application. Previously I accompanied Harold Minnis to Social Security Ocala. Harold applied for ESRD benefits in person on Jan-17-2025 @ 9:00 AM (ESRD) and spoke with Mrs. Nelson, who provided a End Stage Renal Disease Medical Evidence Report form. I provided the ESRD form by email and hand delivery to AdventHealth Ocala and Jeffrey

S. Bromme, Esq., AdventHealth Executive Vice President and Chief Legal Officer. I will forward my emails with AdventHealth, Mr. Bromme to you.

In my view the authorities violated Harold's civil rights and disability rights. U.S. Congresswoman Kat Cammack inquired on Harold's behalf and learned his application for SSI was pending, but due to insufficient work credits, Harold is not eligible for Social Security disability or retirement benefits. Without money, Harold could not pay his \$800 a month rent at [REDACTED], Dunnellon, FL 34432 to his landlord, [REDACTED] who also noted the home is not accessible for Harold. I have video of Harold struggling with a flight of steps to the home. Harold also had interpersonal issues with some of his roommates.

Harold's brother [REDACTED] had a place for Harold to stay at [REDACTED] Umatilla, FL 32784, but probation office Antonio Rameriz said the property was too close to a bus stop. In the past Harold lived at this address.

Lawyers I contacted refuse to help Harold, including a Florida Bar LRS referral, J.W. Chalkley, Esq., and the Morgan & Morgan Ocala law firm. West Marion Hospital caseworker Ms. St. Kitts said there was a "blockage in the county" preventing Harold from getting benefits. I will forward my emails with MCSO general counsel Marissa Duquette.

On January 2, 2025 Harold was homeless. I took him to the Marion County Jail where he voluntarily surrendered, but the jail ultimately refused him. I called 911 on Harold's behalf when he was left stranded outside the jail in freezing weather. So far the authorities have refused my public records request for the voice recording of the 911 call. (I used my iPhone to record part of the 911 call)

Harold's Pre-Release Plan from the Florida Department of Corrections has a referral to Catholic Charities, 1701 NE 9th Street, Gainesville, FL 32609 at 352-378-2868 for eligibility. For several months I have called and emailed Catholic Charities to no avail. Susan Frizzell, the Program Coordinator for HOPWA Eligibility Determination, has not made a determination that I know about. HOPWA is a Federal program that could provide a grant for housing Harold Minnis.

Prior to Harold's release from prison, I was in contact with Warden Randall Polk, and Jerry Waters, Classification Supervisor, Columbia Correctional Institution. In September 2024 the Marion County Tax Collector initially refused to issue a state ID to Harold. I will forward those emails to you. Also my emails with the Marion County Health Department for [REDACTED] treatment.

I am willing to help Harold in any way I can. Thank you.

Dear Mr. Bromme,

Thank you for your email. On Friday January 17, 2025 after our visit to the Social Security office, I accompanied Mr. Minnis to the Marion County Department of Health for further care, and spoke with Anna Gerard, Stephanie in reception, and another woman who said Anna was her supervisor. I explained Harold's situation and answered their questions. I explained to Harold that I had a conflict and could no longer assist him. Pursuant to the advice of the DaVita Kidney Care corporate office, et al., I advised Harold to call 911 if he needed kidney dialysis, and left.

Separately, my assistance to Harold may prejudice his situation because certain local authorities may oppose my efforts. I have explained this to Harold.

Previously I sought the assistance of Harold's elected representative, US Congresswoman Kat Cammack, and The Florida Bar Lawyer Referral Service. Rep. Cammack responded on Dec-05-2024 with a response in part from the Social Security Administration, see attached:

"Unfortunately, Mr. Minnis is not insured for Retirement benefits. He needs 40 quarters of coverage to be insured for Retirement benefits, and he only has 19 quarters. With that being said, he has a pending disability claim for SSI as of 10/29/24. It is only an SSI claim because again, he is not insured for Social Security disability due to his lack of work."

On Dec-27-2024, Ms. Hallie Mallard responded for Rep. Cammack in part: "Unfortunately, our office unable to intervene in legal matters or court case due to the principle of separation of powers. As members of the legislative branch, we are prohibited from influencing or becoming involved in judicial proceedings to ensure fairness and impartiality in the legal system."

On Dec-24-2024, the LRS referral, J.W. Chalkley, Esq., wrote he was unable to assist Mr. Minnis. Separately I contacted the Morgan & Morgan Ocala law firm, but got no response.

It appears law enforcement does not intend to violate the probation of Mr. Minnis, or accept his

voluntary surrender. And there has been no response from Catholic Charities and Susan Frizzell, the Program Coordinator for HOPWA that might provide housing for Harold.

That leaves Harold Minnis with the untenable option to die in the streets of Ocala once he stops kidney dialysis. As a society I believe we can do better. Even a makeshift hospice with palliative sedation would be more humane. <https://www.nytimes.com/2009/12/27/health/27sedation.html>

AdventHealth is in a position to lobby our government leaders for reform. I believe it wrong to for society to shift its obligation for its sick and dying citizens to hospital emergency rooms and expensive ambulance rides. This extraordinary expense is wasteful and adds unnecessarily to the cost of end-of-life care, in addition to the emotional toll on those involved. Thank you.

I am contacting you as Executive Vice President and Chief Legal Counsel for AdventHealth.

AdventHealth has been providing kidney dialysis for Mr. Harold Minnis for the past several months due to End Stage Renal Disease (ESRD). Last night at 11:03 PM Harold called me on the phone and asked me to take him to the Social Security Administration in the morning. Today January 17, 2025 at 8:44 AM Harold was waiting for me at the Emergency Room entrance to AdventHealth Ocala, and I drove him to the Social Security office at 933 E Silver Springs Blvd., Ocala, FL 34470. We spoke with Mrs. Nelson, who provided the attached End Stage Renal Disease Medical Evidence Report form, to be completed by AdventHealth Ocala the provider who is providing kidney dialysis for Harold. Please ask the AdventHealth Ocala medical staff to complete the form so Harold can apply for ESRD Medicare coverage.

During our visit to Social Security, I spoke on the phone with Dr. Colon at the Florida Department of Health in Gainesville about Harold's situation. Dr. Colon referred us to the Marion County Health Department. Back on September 15, 2024 I emailed Marion County Health Department with Harold's Pre-Release Plan from the Florida Department of Corrections. Anne Gerard, Senior Community Health Nurse Supervisor, Florida Department of Health in Marion County, acknowledged on September 18, 2024 my contact on Harold's behalf.

At this time Harold is homeless. Upon release from prison Harold resided in Dunnellon at a home to accommodate persons registered pursuant to Section 775.21 of the Florida Statutes. However Harold and his landlady claim he cannot return because the rent has not been paid, and the home is not equipped for assisted living, with entry stairs but no wheelchair ramp.

Harold is currently on supervised release, probation/parole, and wears an ankle monitor. As I understand, Harold must be housed at the Dunnellon address pursuant to Section 775.21 of the Florida Statutes, unless he is hospitalized. AdventHealth Ocala has been releasing Harold to the street, not his home in Dunnellon, or to any other safe place. This is a problem for several reasons, including the winter weather. On or about January 2, 2025 Harold surrendered at the Marion County Jail for voluntary confinement but the jail refused him. The jail provides in-house kidney dialysis, food, and housing, and is a safe place given Harold is on supervised release.

Harold's Pre-Release Plan from the Florida Department of Corrections has a referral to Catholic Charities, 1701 NE 9th Street, Gainesville, FL 32609 at 352-378-2868 for eligibility. For several months I have called and emailed Catholic Charities to no avail. Susan Frizzell, the Program Coordinator for HOPWA Eligibility Determination, has not made a determination that I know about. HOPWA is a Federal program that could provide a grant for housing Harold Minnis.

On November 27, 2024 I requested DaVita Ocala Regional Kidney Center-west 8585 SW Highway 200, Ocala, provide transportation for Harold to get kidney dialysis three times a week. There is no public transportation available. DaVita Ocala has not responded. DaVita corporate said call 911 for an ambulance and go to a hospital Emergency Room for kidney dialysis.

On December 23, 2024 Case Manager Shorna St. Kitts at West Marion Hospital told me there is a "blockage in the county" preventing the Health Department from providing services to Harold, and suggested the jail is not showing Harold's status as released from custody. Persons held in custody cannot obtain outside benefits. A West Marion case manager also reiterated DaVita's instruction to call 911 for an ambulance and go to the hospital for kidney dialysis.

In addition, other general expenses include gasoline, vehicle payments, insurance and vehicle repairs an maintenance Harold's family has contributed \$70 toward the expenses.

At this time it appears AdventHealth must compete and submit the attached End Stage Renal Disease Medical Evidence Report form for Harold to obtain ESRD Medicare coverage. Due to a conflict with Harold Minnis, I am no longer able to assist him.
